He immediately called Addl. Secretary(Esstt.), DoP&T, and asked her to organize all the meetings due as well as to get implemented the issues agreed in the meetings of the NC/JCM referred to above.

Sub: <u>De-freezing of Dearness Allowance and Dearness Relief payable to the Central Government Employees and Pensioners/Family Pensioners</u>

Ref.: MoF(Deptt. of Exp.), Government of India's O.M. No.1/1/2020-E-II(B) dated 23.04.2020

It is a well-known fact that the COVID-19 Pandemic, that spread across the globe during the previous year 2020, created an unprecedented for situation in our country also.

On the call of Hon'ble Prime Minister, Central Government Employees and Railwaymen in particular stood to the occasion by serving day and night to combat the COVID-19 situation.

Railwaymen as well as other Central Government Employees voluntarily contributed their one-day salary in "PM Care Fund" and they were also ready to contribute more to overcome the economic crisis. However, Ministry of Finance took an arbitrary decision, circulated vide letter under reference above, to freez installment of Dearness Allowance/ Dearness Relief, already approved by the Union Cabinet, to be paid w.e.f. 01.01.2020, and the other two installments, due from 1st July, 2020 and 1st January, 2021, up to 30th June, 2021. This virtually resulted in creating an atmosphere quite demotivational for the Central Government Employees and their families, who had been exerting their best during this Pandemic Period.

As your goodself is aware, Dearness Allowance/Dearness Relief is not granted as a charity, but the same was introduced after sustained struggle by the Central Government Employees to compensate erosion of the real value of their salaries owing to market inflation.

Successive Pay Commissions dealt in detail; the admissibility of payment of Dearness Allowance/ Dearness Relief to the Central Government Employees and Pensioners/Family Pensioners, and recommended its timely payment in two installments every year, one w.e.f. 1st January and the other w.e.f. 1st July, on the basis of increase in Consumer Price Index up to previous 31st December and 30th June respectively.

Unilateral decision taken by the Ministry of Finance, being quite unjustified and illogical, is creating deep sense of discontentment and resentment among the Central Government Employees. This is also against the sprit of the pronouncement made by Hon'ble Prime Minister of India, in his address to the Nation during the COVID-19 Pandemic, neither to throw any employee out of employment, nor to cut their wages in any shape. The Government of India, therefore, should set an example of an **Ideal Employer** by not freezing Dearness Allowance/Dearness Relief.

It would not be out context to mention here that, now almost all the activities have been made operational and National Economy is also improving at a satisfactory pace. As per Government of India's affirment, realization of the GST during previous month has been more than the target.

It would, therefore, be quite appropriate that the freezed Dearness Allowance/Dearness Relief, payable to Central Government Employees and Pensioners/Family Pensioners, should be de-freezed immediately, and its payment should be started forthwith, to provide motivation to the Government Employees to work with more dedication and devotion.
