Subject: Completion of the Prarambh module on the iGOT digital platform by each of the new appointees inducted during Rozgar Melas - reg.

As you are aware, during the Rozgar Mela held on 22nd November, 2022, the Hon'ble Prime Minister launched the Karmayogi Prarambh module, which is an online orientation course for all new appointees in various Government Departments.
